Administration was not aware of this project, and we didn't learn of the publication until after it was published, and the publisher sent copies of the book to the school. We believe that the content of these stories called "Twisted Tails" is incompatible with our school values and culture. In addition, Ocean Academy does not have on file any parental authorization forms that would allow student work products to be publicly released.
