Students will be offered intervention summer programs for bridging skill area gaps and enrichment programs for students to increase content knowledge for at-risk students. Afterschool programs throughout the year will offered for students struggling with courses,

OACS has and will continue to utilize its school nurse, as well as outside professional development training, to ensure that all staff and students are practicing the most up-to-date protocols in regards to safe practices and sanitization in order to stop the spread of COVID-19.
