Dear Commissioner Hespe:

This letter is to advise the Department of Education that we are in full support of "Ocean Academy Charter School's" application to establish an elementary charter school in Lakewood.

As you are aware, all of Lakewood Public Schools are labeled by the Department of Education as significantly lagging in academic performance. The system has been under the guidance of a state monitor, Michael Azzara, who has veto power over the Board of Education and Superintendent. Other state monitors have been brought in to assist Mr. Azzara. To say this school system is broken would be an understatement.

Lakewood's pubic school community is one of over 80% free & reduced lunch students; thus, tuition based alternatives are not realistic and there are no elementary schools in a reasonable distance participating in the Interdistrict School Choice program.

The Founders behind this charter school have the knowledge, experience, and abilities to start and maintain a high performing school and will ensure accountability to the State and the school constituency.

In addition, the school has the support of many church, civic, and community leaders. The founders have outreached to the constituency at large through many avenues and have gathered more than 1,000 signatures of residents looking for school choice.

We are looking forward to celebrating an alternative choice for Lakewood's public school students in the near future.

The Lakewood Public School District is dysfunctional as evidenced by the many Asbury Park Press articles regarding financial and educational irregularities.

The Association is grateful to the Department of Education for the State Monitor. Although it appears that the finances are being straightened out, there are still outstanding areas such as governance, operations, and instruction.

Due to the high level of poverty of our community, education alternatives are not available. Due to the demographics of our town, a majority of representatives from the school community cannot be elected to the Board of Education. Due to a monopoly, our children are locked into an incompetent school system that would not be tolerated in any other NJ community.

We are asking for the same opportunity that other distressed areas such as Camden and Newark have been given. We are asking for a Charter School that will be directly and fully accountable to the State and will serve our children well.

I write to express the strong support of the Latino Leadership Alliance of New Jersey (LLANJ) for the approval of charter application being submitted by **Ocean Academy Charter School**. LLANJ considers access to high quality educational opportunities the cutting edge civil rights issue of our times. This is because in New Jersey, while there are many outstanding public schools, some of the best in the nation, there are too many failing public schools such as Lakewood.

Within this construct it is also true that Latino and Black children are under-represented in the great schools, and over-represented in the failing schools. For this reason, LLANJ has vigorously advocated for the expansion of choice options for New Jersey Parents, and it has supported the creation of high quality charter schools in New Jersey for over a decade.

In light of the foregoing, we are very supportive of the creation of a charter school in Lakewood, where the overwhelming majority of children attending the public schools are Latino (over 80%) and over 75% of elementary school students speak Spanish at home. Our review of educational outcome data at the elementary school level in Lakewood reveals that partially proficiency rates are trending greater, rather than shrinking, and the percentage of partial proficiency in Language Arts in the 3rd to 6th grade is horrifically high, well exceeding 50%.

Educational outcomes are the ultimate barometer of success in public education, and we know from our constituent Latino families that they have high expectation or our children's' educational success. The creation of a charter school in Lakewood is an important opportunity that should not be passed up or delayed; time is of the essence for our children when it comes to accessing high quality educational opportunities.

We urge you to approve the application of **Ocean Academy Charter School**. Thank you for your courteous attention to this matter.

I am the Priest in Charge of All Saints Episcopal Church in Lakewood and am fully aware of the challenging issues confronting Lakewood Public Schools. Many of our parishioners have children attending the local public schools and the anomalous circumstances of this school system are a daily discussion at our parish. We see hundreds of people on a weekly basis as we have a centrally located, soup kitchen, food center and a thrift store serving the community. We also see many people seeking overnight shelter in inclement weather, for we provide shelter for a limited number of people in our facilities. Overall this community is greatly disadvantaged.

The majority of students attending Lakewood Public Schools are Hispanics/Latinos and a large majority of that group is new immigrants from Mexico who have come to our country for a better way of life for themselves and their children.

We have found that even though the Superintendent, Administrators, & Teachers are trying to provide a good education and environment for students, the district itself is continuously embroiled in governance and financial issues. Sadly, Lakewood Public Schools are not meeting the academic and cultural needs of the students.

Last year, I wrote a letter of support for an application for a new charter school for Lakewood students. Unfortunately, the Department of Education did not approve of the charter.

This year our parish is once again in support of establishing a charter school for Lakewood's public school students. We are so dedicated to this endeavor, that I have volunteered to be a member of the charter's founding board!
